## ANETH CHAPTER BOARDS, COMMISSIONS AND COMMITTEES

### **Authorized Local Emergency Response Committee (ALERT)**

Committee consists of five (5) members, all of whom shall serve a staggered term of three years. Duties of committee members shall be to plan and prepare a Chapter Emergency Response Plan that will address any disaster and emergency situation in which there is a need for response assistance at the Chapter-Community level. This plan will serve as a foundation for the further development of detailed plans, procedures, and policies so efficient and effective response activities can be implemented. The Chapter Emergency Response Plan will describe how the Chapter Government will handle emergency and disaster situation within its jurisdiction.

### **Community Land Use Planning Committee**

Committee consists of five (5) members, all of whom shall serve a staggered term of 3 years. Duties of committee members shall be to review/amend the Chapter's current Land Use Plan and propose new uses of land to meet the changing needs in the community. Members shall project future community land needs for residential, commercial, industrial, and public purposes. Interested members must be able to provide valuable contributions to the overall land use planning process.

### **Housing Assistance Committee**

Committee consists of five (5) members, all of whom shall serve a staggered term of two years. The Housing Assistance Committee as a whole is vested with the responsibility of providing assistance to eligible Navajos and making proper eligibility determination for material/labor assistance and identifying need based upon careful analysis of housing needs and economic conditions of applicants.
